## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2019 of **Llanwrtyd Wells Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis of Qualification


#### Annual Governance Statement

In my opinion, the positive assertions made in the Annual Governance Statement are not consistent with the Council's internal controls and governance arrangements for the year:

- Assertions 1 and 2: The Accounting Statement included in this Annual Return has been amended from that first submitted for audit. Work carried out by the then interim clerk after the accounts were approved identified significant errors in the Council's accounting records for the period 2017-8 to 2019-20. The Council had not maintained proper accounting records for this period and had not properly reconciled the bank accounts.
- Assertion 2: The Council's normal procedure is for all payments to be approved by the Council. During 2018-19 payments were made without prior council approval.
- Assertion 3: The Council does not publish on its website information that it is required to publish by the local Government (Democracy) (Wales) Act 2013 and the local Government and Elections (Wales) Act 2021

### Other matters and recommendations

There are no further matters I wish to draw to the Council's attention.
